

3CI SUPERCITY TERMS OF ACCESS

Capital City Church International, being an unregistered association not for gain ("**3CI**") runs a children's church ministry for minors aged 3 to 13 ("**Supercity**") on a Sunday. By leaving the minor under my care ("**the Child**") with a member of the 3CI Supercity team ("**the Team**"), the following terms shall be applicable to me, the Child and all guardians of the Child (collectively, the "**Guardian**"). Should any Guardian decline any of the terms below, the Guardian should not allow the child to enter Supercity ministry area or should immediately remove the Child from the Supercity ministry area and care of the Team.

Access Control. Only the Guardian may gain access to the Supercity ministry area on presentation of a wristband or sticker matching that of the Child, and the Child will only be released to the relevant Guardian on presentation of same. The Guardian understands that the Supercity team has been given the authority by the 3CI Eldership to run Supercity in an orderly, respectful and well-disciplined manner, and in keeping with this, 3CI reserves the right of admission to any child.

Medical Emergencies. Supercity shall take reasonable care to avoid harm and injury to the Child while the Child is in the care of the Team, including by ensuring that all Supercity volunteers have acquired police clearance certificates, and that at least one person with emergency first aid training is available to assist the Child ("**Medical Volunteer**") in the event of an emergency. In certain emergency situations there may be insufficient time to contact the Guardian, or to refer to medical records of the Child. Accordingly:

- the Guardian authorises the Medical Volunteer, the Team and/or 3CI to utilise the available emergency services they deem most reasonable and appropriate in the circumstances to avoid harm and injury to the Child; and
- the Guardian hereby delegates to the Medical Volunteer, the Team and 3CI, in such circumstances, the power to authorise whatever medical treatment they in their sole discretion deem necessary to avoid harm and injury to the Child, and in doing so agree that the Medical Volunteer, the Team and 3CI should act *in loco parentis* (with the same authority as a parent or guardian).

Guardian's responsibility. The Guardian acknowledges that they have fully familiarised themselves with the nature of Supercity and its operations, and must inform the Team in advance of any special requirements, ailments or allergies in respect of the Child. The Guardian must take

all reasonable care to avoid harm and injury to the Child while the Child is in the care of Supercity. This includes (but is not limited to):

- A Guardian must collect the Child immediately after any service held at 3CI.
- A Guardian must remain at 56 Saal Street, Zwavelpoort, Pretoria, 0081 ("**3CI Campus**") for the period when the Child is with the Team.
- A Guardian must provide the Team with their cell phone number and keep their cell phone on their person (on silent and vibrate) in case they need to be contacted by Supercity for any reason.

Personal information. The Guardian acknowledges that by registering the Child for Supercity, 3CI processes personal information of both the Child and the Guardian. Accordingly, the Guardian:

- warrants that they are competent persons in respect of the Child as contemplated by the Protection of Personal Information Act 4 of 2013 ("**POPIA**");
- as a competent person (as defined in POPIA) consents to the processing of the Child's personal information; and
- consents to the processing of the Guardian's own personal information.

3CI makes use of the website <https://www.planningcenter.com/> ("**Planning Center**") to register and store the personal information of the Child and the Guardian, and 3CI has accordingly concluded a data processing agreement with Planning Center as required by POPIA. The Guardian hereby consents to 3CI disclosing the personal information of the Child and the Guardian to Planning Center for purposes of storage (including cross-border storage) of the Child's and the Guardian's personal information. Photographs and Videos. The Guardian hereby consents to 3CI and Supercity publishing any photograph or video footage captured of the Child.

Monitoring. 3CI has the right to monitor the Supercity ministry area by CCTV footage.

Use of Playground facilities. The Guardian acknowledges that the Child's use of the playground and jungle gym facilities located in the Supercity ministry area is at own risk and is subject to the indemnifications below and in the 3CI premises.

Indemnification. The Guardian hereby irrevocably indemnifies and holds harmless 3CI, the Team, the Medical Volunteer and any of 3CI's elders, volunteers, staff, agents, members and employees ("**the Indemnified Parties**") against any loss, damage or injury which may be

sustained by the Child from whatever cause, excluding gross negligence, while the Child is in the care of Supercity. The Guardian hereby irrevocably waives any and all claims for loss, damage or injury to the Child, that the Guardian has or may have against any of the Indemnified Parties as a result of the Child's participation in Supercity. The indemnities and releases from liability are given by the Guardian in their personal capacity in respect of any claims in their own names, and on behalf of the Child, in respect of any claims that may be made by or on behalf of the Child and are binding on their (and the Child's) heirs, executors, administrators, representatives and themselves.
